One-Cent Sales Tax

Capital Improvement Sales Tax

- 35% Neighborhoods (PIAC), 25% Street Preservation and Complete Streets the rest is for debt and other maintenance
- Sales Tax year 40 revenue est minus TIF redirection- \$85.8 million
- Neighborhood portion- \$30 million
- Divided equally by 6 districts is \$5 million per district

A PIAC application must be submitted each year funding is needed for consideration

Last year received almost 1,000 applications

Amount of requests equaled \$751,756,241

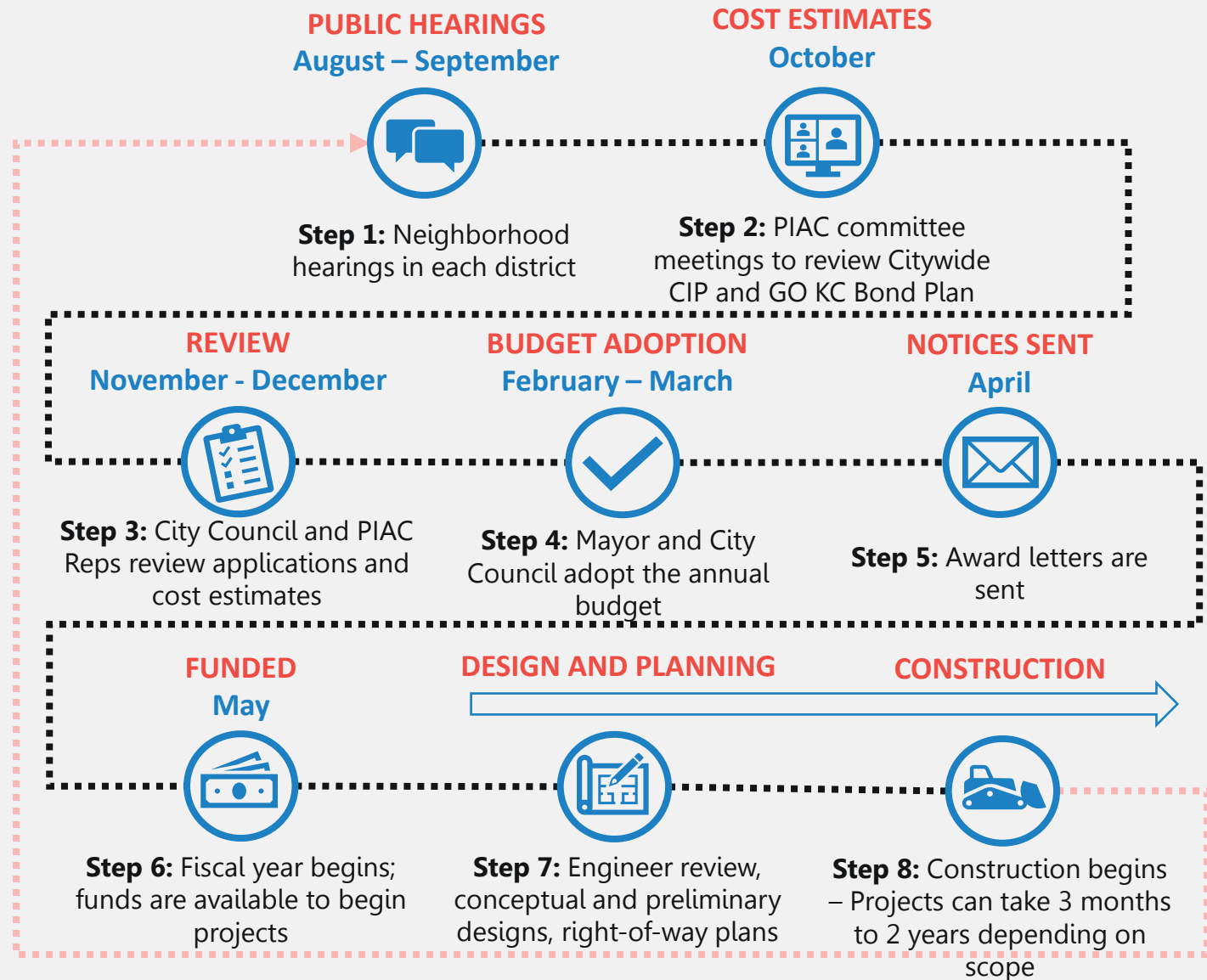

What to expect if your project is funded?

- Funding is available for the projects funded as of May 1
- Project manager will get assigned the project and they will begin work on the funded project
- If construction is funded, please keep in mind that there are many steps a project manager must go through and many times the earliest construction can start is spring the following year
- If the project needs a study, design, or ROW for example, you might not see visible construction for your project until these steps are completed and construction money can be obtained
